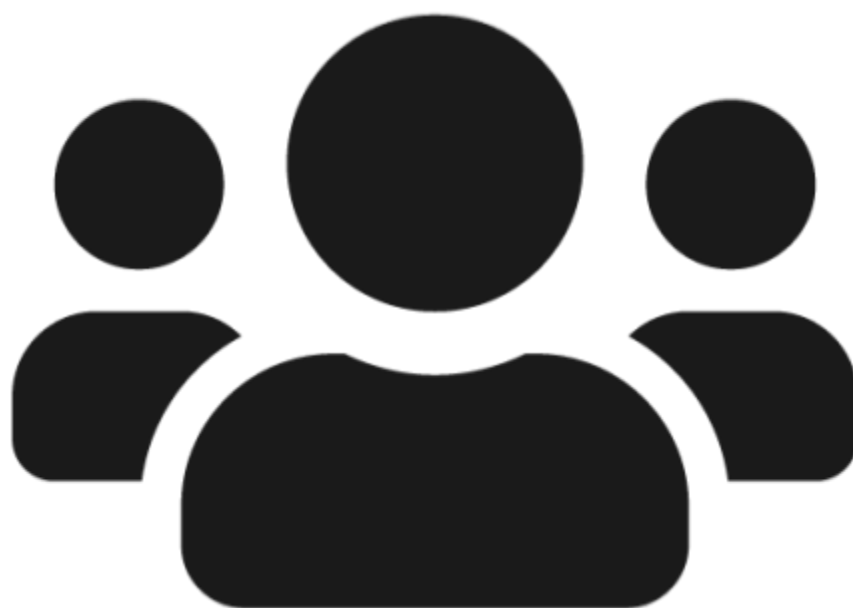

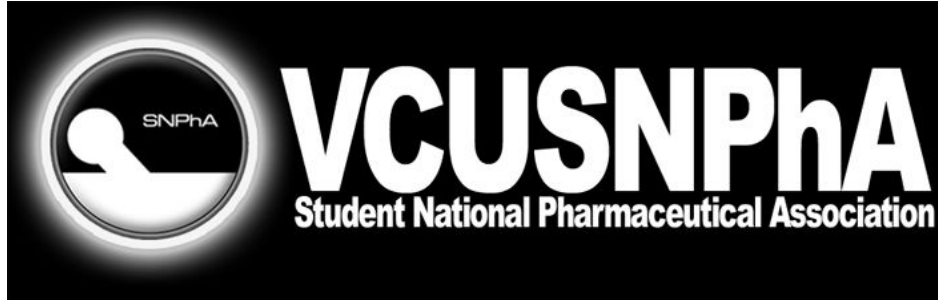

# Virginia Society of Health-System Pharmacists Student Chapter (SVSHP)



## **Mission and Purpose:**

The SVSHP chapter at the Virginia Commonwealth University School of Pharmacy is a student chapter of the Virginia Society of Health-System Pharmacists, which is a state chapter of the American Society of Health-System Pharmacists. Membership in SVSHP also includes membership to the state and national parent organizations.

VSHP (Virginia Society of Health-System Pharmacists) is the professional society that represents pharmacists who serve patients in Virginia across the continuum of care in integrated health care systems. Components of such systems include acute care, ambulatory care, home care, intermediate care, long-term care, and other components of health-systems.

ASHP (American Society of Health-System Pharmacists) is the 31,000-member national professional association that represents pharmacists who practice in hospitals, health maintenance organizations, long-term care facilities, home care, and other components of health care systems.
